# Wetland Replacement Program Opportunity

Policy Brief

## AT ISSUE

Municipalities in Alberta have been presented with an opportunity to become actively involved in wetland management through the Province of Alberta's new Wetland Replacement Program. The Province is attempting to secure municipal involvement and has approached Wheatland County directly due to our high priority location for wetland replacement. Municipal involvement in the Wetland Replacement Program requires that Wheatland County sign a Memorandum of Understanding (MOU) with the Province committing us to seek wetland replacement opportunities, submit a minimum of one application for a wetland replacement opportunity per year, and carry out wetland replacement work that is approved and 100% funded by the province.


Wheatland County staff have participated in conference calls with provincial staff responsible for the program to obtain further information and have initiated critical thought about the fit of the Wetland Replacement Program within Wheatland County. We now require the Board's direction in determining how best to proceed. To this end, we present three possible courses of action and a recommendation as described in the remainder of this brief.

## **BACKGROUND INFORMATION**

- When wetlands are impacted by any entity including municipalities, developers, industries, or landowners, the *Alberta Wetland Policy* offers two options: permittee-responsible wetland replacement (do it yourself) or payment of compensation to a provincial fund slated for wetland replacement (more cost-effective).
- The provincial fund for wetland replacement is growing. The collecting, holding, and use of funds has been controversial; resolutions discussed at RMA noted magnitude of the expense for necessary impacts like road construction, ability for municipalities to make use of funds collected, and discontent with funds transferring out of the region in which costs were incurred.
- In response to public perspectives, the Province created the Wetland Replacement Program
  with mechanisms for prioritizing use of funds in the watersheds from which they came, and for
  creating equal access to dollars by any entity capable of restoring or creating wetlands on the
  landscape through an application process.
- Wheatland County contains portions of both the Bow and Red Deer River watersheds. County
  operational contributions to provincial compensation fund allocations in each watershed are
  outlined below:

 Fund distribution priorities are based on rates of loss and compensation collected per watershed (hydrologic units) since implementation of the Alberta Wetland Policy. Wheatland County is identified as high priority for wetland replacement as per the maps below:



HUC 4 Map Excerpt (Broader Units)


HUC 6 Map Excerpt (Finer Units)

- The Bow River Basin is of particular interest to the program. To keep funds within the watershed, replacement opportunities must be found in the rural portions of the Bow Basin.
- Wetland replacement efforts are actively occurring within Wheatland County through charitable
  organization, Ducks Unlimited Canada (DUC). DUC seeks partnership with interested private
  landowners to restore historically drained wetlands. DUC successes in Wheatland County in the
  last five years are summarized below:

\*Wetlands restored by DUC between 2015-2020 were not funded by the provincial wetland compensation fund described above. They represent mitigation funds collected through previous processes and invested in the County. Numbers were provided by DUC.

\*\* This value does not include project costs for staff time, contractors, appraisals, legal fees, materials, and other costs associated with wetland restoration.

#### **RESPONSE OPTIONS**

#### 1. Sign the Wetland Replacement Program MOU with Alberta Environment and Parks (AEP)

- Signing the MOU indicates our commitment to seeking and identifying potential wetland restoration or construction opportunities and submitting a minimum of one proposal per year for a wetland replacement project. It is not legally binding.
- Wheatland County would become responsible for advertising, landowner discussion and negotiation, and development of project proposals.
- Proposals require qualified technical support to complete which would require a budget of approximately \$25,000 per proposal for work that must be completed by qualified consultants.
- Proposals accepted by the Province result in a service contract between AEP and the municipality to complete wetland replacement projects. AEP funds 100% of wetland restoration or construction work and may partially fund municipally required infrastructure, such as stormwater ponds designed to function like wetlands or gravel pits reclaimed to include wetlands, on a case-by-case basis.
- Staff resources are required for landowner agreements and contract management for engineers, qualified environmental specialists, surveyors, and earthworks towards completion of a project. Monitoring, reporting, inspection and maintenance are required during a 10-year contract period post-construction with continued, AEP-funded use of contractors and consultants.

#### 2. Do not sign the Wetland Replacement Program MOU – no action

No action occurs on our part. We respond to the Province with our disinterest and do not take
part in or increase efforts to promote wetland replacement within our municipality.

#### 3. Support wetland replacement in Wheatland County through promotion of existing efforts

 We respond to the Province with our disinterest in actively participating in the Wetland Replacement Program. Instead, we recognize and support DUC's existing effort to restore wetlands in our municipality through advertisement, promotion, and identification of opportunities via existing agricultural conservation programs and outreach.

Possible favourable applicant due to participation.</li> <li>Involvement in the program indicates positive environmental stewardship behaviour on behalf of our municipality and its producers.</li> </ul>	<ul> <li>Possibility of losing \$25,000 per unsuccessful proposal is a risk. Avoid risk, cost, and workload associated with undertaking activity directly by instead supporting existing efforts.</li> <li>Positive stewardship initiative which reflects positively on the municipality and its producers.</li> <li>Contribute to the restoration of wetlands in Wheatland County and subsequent increase in ecological benefits including protection of built infrastructure like roads, bridges, and culverts.</li> </ul>	<ul> <li>Possibility that DUC operations change, unforeseen risk of no longer having wetland restoration activity occurring in Wheatland County. We may re-evaluate our approach if this occurs.</li> <li>Public relations risk; DUC historically was not favoured by agricultural producers due to previous aspects of their operations. This sentiment still exists amongst some producers today, but there has been improvement due to DUC program changes. Partnership or promotion may be viewed unfavourably, although there is an opportunity for the municipality to help improve community mindsets through positive promotion.</li> </ul>

### RECOMMENDATION

With consideration given for the state of the economy and financial implications currently facing municipalities, and the costs, opportunities and threats associated with each potential response option as evaluated above, the professional recommendation of staff is to decline participation in the Wetland Replacement Program at this time and instead support wetland replacement in Wheatland County through promotion of existing efforts by choosing **Option 3**.

Promoting the activities of a charitable organization like DUC that is already in the business of wetland restoration in our area may offer the benefit of increased occurrence of wetland restoration projects in our municipality and the resulting exchange of funds and ecological benefits to our ratepayers and landscape without the need for additional staff workload, budget, and risk on behalf of Wheatland County. As conditions or considerations change, we have the flexibility to re-evaluate this approach.
