The purpose of this application is to redesignate +/-4.00 acres from Agricultural General (A-G) District to Country Residential (C-R) District within SE-21-24-26-W4M for the purpose of facilitating a future subdivision. The subject parcel is 21.15 acres and currently used for Hay farming and contains a private dwelling, barn and farm buildings. The area to be redesignated is currently undeveloped, but there are plans for a private dwelling, private well and a private sewage disposal system. The balance of the parcel will remain Agricultural General (A-G) District.
