Bylaw 2020-30: First Reading, Agricultural General to Rural Business District

Division: Division 5

The applicant is applying to redesignate 86.45 acres within NE-27-24-25-W4M from Agricultural General to Rural Business District in order to expand and diversify development on the property. It is adjacent to the Town of Strathmore and currently contains a residential dwelling, with an approved development permit for a Market Garden. The applicant has hosted agricultural tourism events on this parcel in the past, which were stand alone events held in conjunction with a larger event such as Open Farm Days. These occasional events did not require a Development Permit. However, the expanded uses that will include an Entertainment Venue, Agri-Tourism Business, and a Farmers Market, will require a development permit once the land is redesignated to the appropriate district.

At the time of writing this report, no concerns were raised by external agencies or internal departments.
