<b>Application</b>	A Bylaw of Wheatland County for the purpose of amending Land Use Bylaw No. 2016-01 to redesignate 17.48 acres within NW-12-26-22-W4M from Agricultural General (AG) District to Parks and Recreation (PR) District as shown on the attached Schedule ‘A’ forming part of this Bylaw.
<b>Presentation</b>	G. Allison, Planner I, presented the request for decision for Bylaw 2020-32. The application is to redesignate 17.48 acres from Agricultural General District to Parks and Recreation District to bring this parcel into alignment with the recreational uses that exist on site. Staff noted that the subject parcel is owned by Wheatland County and is located next to the Severn Creek reservoir. Note: the request for decision and supporting documents were provided to Council for review prior to the public hearing; a copy of the documents was included in the Council agenda package.
