# <u>Report</u> Division: County-wide

A decision was made by Council on June 2020 to change direction from the broadband partnership and hire a Project Manager to facilitate Wheatland County's interest on improving broadband services. The improvement of services was with the underlying goal of making Wheatland County services competitive and increase investment in a much timelier, risk averse and cost-effective fashion.

As such, a comprehensive Request for Proposal (RFP) was submitted on July 21<sup>st</sup> to solicit a proposal for an experienced Project Manager to take on this role for Wheatland County. This includes understanding the County's current state, needs and developing a comprehensive Wheatland County broadband strategy, subsequent funding, and timelines in which to base and manage a multi-year project plan that will bring in improved, expandable, and sustainable broadband services.

Several staff reviewed proposals that were submitted and independently filled in a matrix that evaluated each proposal. Top candidates were then contacted for first and second interviews and again staff individually evaluated each candidate. Through the selection process, Tricon Solutions Inc. was rated as the top vendor.

Administration is recommending that Council award the role of Project Manager for the rural broadband project to Tricon Solutions Inc.
