## Bylaw 2020-37 Public Behaviour Bylaw

#### **Recommendation from Administration**

- Resolution #1 That Council move <u>First Reading</u> of Bylaw 2020 37, Public Behaviour Bylaw, being a Bylaw to regulate problematic social behaviours that may have a negative impact on the enjoyment of public spaces within Wheatland County.
- Resolution #2 That Council move Second Reading of Bylaw 2020 37, Public Behaviour Bylaw
- Resolution #3 That Council provide unanimous consent to proceed to Third Reading of Bylaw 2020 37, Public Behaviour Bylaw
- Resolution #4 That Council move Third and Final Reading of Bylaw 2020 37, Public Behaviour Bylaw

#### **Chief Administrative Officer's Comments**

#### Report

#### **Division County-wide**

A bylaw mechanism that provides oversight of social behaviour results in safe public spaces. Bylaw 2012 - 80 was reviewed because there were provisions that were deemed to be unenforceable and out of date. These provisions no longer contribute to safe public spaces.

The proposed amendments remove the unenforceable sections and modernizes the wording of some definitions and sections therein. The proposed amendments also provide sections dealing with smoking and vaping of Tobacco and Cannabis in public places, and prescribed distances of certain areas around public buildings.

In preparing the revised bylaw, staff reviewed bylaws from jurisdictions that encounter similar public behaviour concerns and have incorporated some of them into the recommended amendments. After this proposed bylaw was drafted and discussed at a Planning and Priorities Committee meeting, it was circulated to all the RCMP detachments that provide service to Wheatland County for their comments, and none were received back.
