## Key Issue(s) / Concepts Defined

Define the topic, reference background material and state question to be answered The Strathmore & District Chamber of Commerce has been representing businesses of all sizes in the Town of Strathmore and Wheatland County. It is an organization formed by progressive individuals and businesses who work together to progress the field of commercial, financial, industrial and civic interests in the community.

The organization is governed by a Board of Directors elected at the Annual General Meeting or appointed by the Board for an interim period. The Board sets the policies and directions of the Chamber of Commerce, with the goal of building interest in business through networking, member benefits and education.

The Chamber has recently initiated discussions surrounding changing the name to be more representative of both municipal jurisdictions (the Town of Strathmore and Wheatland County) and has suggested changing the name from the Strathmore & District Chamber of Commerce to the **Strathmore Wheatland Chamber of Commerce**. This name change is aimed at representing the businesses and interests of both jurisdictions equally.
