# Bylaw 2020-17 – Animal Control

# **Recommendation from Administration**

THAT Council Approve Bylaw 2020-17:

#### **Chief Administrative Officer's Comments**

#### Report

After an application from a ratepayer to have chickens within a hamlet as emotional support animals, Council directed staff to develop a process for ratepayers to make application for Emotional Support Animals within hamlets. Common emotional support animals tend to be livestock such as chickens and pot-bellied pigs.

Under the Land Use Bylaw, livestock animals are not allowed to be harboured within hamlet boundaries. This bylaw allows for ratepayers to apply for an Emotional Support Animal Permit if there is a need for that animal based on the conditions listed in the bylaw within a Hamlet.

In the bylaw there is a clear guideline what constitutes an emotional support animal, the conditions that must be followed in the case of granting an Emotional Support Animal permit. The sections regarding Emotional Support Animal Permits Only applies to Hamlets as listed in the definition section.
