#### **Report**

- On August 20, 2019, Council approved the rescindment of Safety Policies 10.1-10.14 with the stipulation that the policies would be replaced with internal Administrative Directives.
- Council requested that Safety Policy 10.1, outlining the organization's commitment to the health and safety of our employees, contractors, and the general public be revised and remain open to the public as Section 10 – Safety Policies, Safety Policy 10.1. On September 17, 2020, Council approved Safety Policy 10.1.
- On February 4, 2020 Council accepted Safety Administrative Directives 10.1.1-10.5.1 as information.
- Attached are Safety Administrative Directives 10.6.1-10.10.1 as information. The attached Safety Administrative Directives include:
  - 10.6.1 Other Parties at or in the Vicinity of the Worksite
  - o 10.7.1 Inspections
  - 10.8.1 Emergency Preparedness and Response

  - 10.10.1 System Administration

The completion of these Safety Administrative Directives finalizes the transition from Safety Policies to Safety Administrative Directives.
