2.1.1 Bylaw 2019-36 - Re: Land Use Bylaw Amendment - Speargrass

Public Hearing – Bylaw 2019-36 (Land Use Bylaw Amendment - Speargrass)

A Bylaw for the purpose of amending the Land Use Bylaw No. 2016-01 to update Speargrass Low Density Residential District and Speargrass Medium Density Residential District regarding Dwelling, Secondary Suites, RV Storage, and Fences. Note: if approved, the proposed amendments will impact the Community of Speargrass pertaining to the following: removal of Dwelling, Secondary Suites as a use; limiting the length of time RVs are permitted to be stored on personal property; requirement of development permit for fencing. A copy of the request for decision and supporting documentation was included in the agenda information package for Council review.

Following the public hearing, members of Wheatland County Council and staff continued to discuss the proposed changes to the Speargrass Land Use District (Bylaw 2019-36) and its effect on the community, current and future development, and enforcement. Note: Councillor Biggar's initial motion for second reading of Bylaw 2019-36 was withdrawn based on discussion.
